Landscape and Pool /Clubhouse Committee

- Pool Committee duties include:

Note: The Goodwin Management Company provides, via a supplier contract, weekly pool maintenance which includes 3 visits/week April to September with a lighter schedule from October to March. Therefore, the Pool Committee does not need to address these areas except as noted below.

- Maintain/replace/fix pool area furniture & other cosmetic items including:
 - Check lounges for torn material.
 - Check chairs and lounges for broken bolts.
 - Check umbrellas for 4 tables and replace as needed.
 - Check plants in pots around pool and replace as needed.
- Ensure that landscape inside and outside of pool area is in good shape.
- Ensure that there are sufficient trash and recycle bins.

- Ensure that signage is in good readable condition.
- Report any items of concern related to pool & hot tub maintenance to Goodwin.

➤ Landscape duties include:

Note: The Goodwin Management Company provides, via a supplier contract with Sunset Landscaping, weekly front yard seasonal maintenance and common areas maintenance. The committee does not need to address these areas except as noted below.

- Review Common Area trees yearly for trimming.
- Report any weekly items to Goodwin.
- Review all common areas and prepare lists and manage projects needed to beautify the community.
- Prioritize projects by order of importance for community.
- Get quotes on projects and develop a yearly budget with the board. Look for ways to reduce costs through residents helping, where possible, on projects.
- Implement and manage all projects approved by the board yearly.
- Manage expenses on all approved projects to be within or below budget.

- Consider update requirements and present them to the board for consideration.
